CITY COUNCIL MINUTES REGULAR MEETING SEPTEMBER 22, 2015

The Winnemucca City Council met in regular session on Tuesday, September 22, 2015 at 2:00 p.m. in the City Hall meeting room. Present: Mayor Di An Putnam and Councilmen Mike Owens, Theresa Mavity, Jim Billingsley and Paige Brooks. Absent: Councilman Ken Tipton. Staff present: City Manager Steve West, City Attorney Kent Maher and City Clerk Lorrie Haaglund.

CALL TO ORDER:

Mayor Putnam called the meeting to order at 2:00 p.m.

APPROVAL OF MINUTES:

The minutes of the September 8, 2015 regular City Council meeting were reviewed and Councilman Brooks moved for approval as submitted. Motion carried unanimously.

APPROVAL OF WARRANTS:

The warrants were reviewed and Councilman Owens moved for approval as submitted. Motion carried unanimously.

BUSINESS IMPACT DETERMINATION

VARIANCE REQUEST VW-15-11 / REDUCE SIDEYARD SETBACK / WEST

Mayor Putnam presented a variance application by D. Stephen West to reduce the south side setback from five feet to one foot to allow for the construction of a carport on property located at 4188 Foothill Drive, Assessor's Parcel No. 3638-33-105-017. Putnam noted the setback only affects one corner of the property because of the way the property line runs at an angle. Betty

Lawrence, Planning Department, said a letter was received from Offenhauser (the original developer of the subdivision) stating the recorded declaration of restrictions for the subdivision should be honored and no changes permitted. Lawrence stated the City does not enforce or research CC&Rs. Lawrence noted there were seven variances granted from 1982 to 2004 for garages or adding to existing structures in the Offenhauser subdivision (which is subject to the CC&Rs) and Lawrence said she is sure there are others. Councilman Billingsley asked if the other variance requests were for set back reductions. Lawrence stated yes. Putnam asked if any letters to the same effect were received on those requests. Lawrence stated no. City Attorney Maher stated the CC&Rs are private zoning issues enforced by the owners of the property, and they are not relevant to variance requested from zoning requirements. Councilman Owens moved to approve, based on staff findings and recommendations, variance VW-15-11 to reduce the south side setback from five feet to one foot at 4188 Foothill Drive, Assessor's Parcel No. 3638-33-105-017. Motion carried unanimously.

ABANDONMENT REQUEST / EAST SIXTH STREET ADJACENT TO BLOCK 35 / GIURLANI

John Milton, Desert Mountain Surveying, the agent for the Lorraine Giurlani Revocable Trust, requested the City initiate abandonment proceedings for a five feet in width strip of land of East Sixth Street adjacent to Block 35 of the Town of Winnemucca, APN's 3638-29-110-001, -002, and -003. There is an existing single family dwelling that encroaches into the street right of way and if the abandonment is approved, the property will then be inside the property line. Councilman Brooks moved to direct staff to proceed with the abandonment procedure and set the matter for public hearing. Motion carried unanimously.

GROUNDWATER PROTECTION PROGRAM PRESENTATION / RESOURCE CONCEPTS INC.-NEVADA DIVISION OF ENVIRONMENTAL PROTECTION

Kim Borgnizzer, Division of Environmental Protection-Bureau of Water Pollution Control, explained the Nevada Division of Environmental Protection (NDEP) and the Bureau of Water Pollution Control (BWPC) has contracted with Resource Concepts, Inc. (RCI) to provide technical assistance for communities and public water systems under the Integrated Source Water Protection Program (ISWPP) to establish or update wellhead protection plans. Lynn Fonge and Jill Sutherland, RCI representatives, presented information on how the technical assistance will focus on defining of protection areas around drinking water sources; in Humboldt County this includes 44 public water system wells and 3 spring systems. The project is supported with funding from the Bureau of Water Pollution Control. Borgnizzer said it takes less effort and money to protect groundwater than to clean it up. The plan will document the public drinking water resources throughout Humboldt County, develop protection measures for those public drinking water resources, and facilitate County-wide collaboration for education, development and implementation of the plan. Fonge stated the plan development process includes forming local planning teams to gather water system information, mapping groundwater capture zones around wellheads, identifying facilities or activities near wells that might release pollutants, and developing strategies and an action plan to protect drinking water quality. RCI will also assist in studies for new infrastructure projects, closure of unused wells and wellhead security improvements. Sutherland said RCI staff will be contacting the city to set up a meeting to coordinate the development of a local planning team. Active involvement from each public water system is important to ensure the input and concerns from each system are being addressed in the plan. Once developed by the local planning team and RCI, a draft plan will be

presented to the various governing boards for acceptance and approval. The approved plan will then be submitted to NDEP's ISWPP for endorsement; with State endorsement, communities and water systems will become eligible for future assistance to implement local source water/wellhead protection strategies and actions. Borgnizzer said NDEP is requesting a letter from the City Council supporting the program and confirming participation in the process. Councilman Billingsley asked if the City will be able to commit staff for the project. City Manager West stated he will be able to participate. Mayor Putnam asked if the City will work jointly with the County. West stated there are some County-wide goals that should be worked on together, but once the implementation starts, the City will need to work separately. The City has a wellhead protection plan in place, but it needs to be updated to include the planned Well #8. County Administrator Dave Mendiola said the County's perspective is that this is a new process and the City Engineer's assistance and knowledge are needed to put the County plan in place. Councilman Owens moved to authorize the City to write a letter of support for the Ground Water Protection Program and commit staff time for the program. Motion carried unanimously.

RECREATION COMPLEX PROPERTY TRANSFER PROPOSAL / WINNEMUCCA BOYS AND GIRLS CLUB

Mayor Putnam stated the City needs to seriously consider how to best reach the goal of completing the remaining recreation facility improvements. The City cannot afford to complete the project and must consider the best method to obtain private funding. The City has done well in getting the soccer fields in and the Boys and Girls Club is on track for the construction of their building on the portion of land already deeded by the City to them. The City needs to be able to maximize the potential for funding for the project and doesn't have the potential that the Boys and Girls Club does for raising funds from the private sector for the community recreation project. Putnam said the City is a long ways from being able to fund new baseball fields, a swimming pool and the other planned facilities. Funding would come easier through the Boys & Girls Club. The City has already placed the City recreation programs with the Boys and Girls Club to run and develop, and they have done a great job. Putnam suggested the property be transferred to the Boys and Girls Club to facilitate the development of the recreation facilities. City Attorney Maher stated when transferring land belonging to the City, State law allows the City to transfer it without consideration or exchange of money if the property is used for charitable or civic purposes. A resolution could be adopted which included conditions if the Boys and Girls Club cease to use the property for the purposes it is conveyed for, then the property will revert back to the City. Councilman Billingsley asked if they could include a time limit for the improvements. Maher said such a provision could be included. Chad Peters, Executive Director of the Winnemucca Boys and Girls Club, said they have already laid some of the ground work for the development of the property to happen. The Boys and Girls Club has established a good relationship with the prospective donors that are capable of making the goals happen sooner, rather than later. Peters said the Pennington Foundation, which funded a portion of the first phase of the recreation facilities, made it clear they want to see the entire area of property developed. Peters asked if the property is conveyed to the Boys and Girls Club, will they be able to modify the improvements shown on the master plan. Maher stated the City could have a condition that if the Master Plan changes, the City input is required, thus it will not be restrictive to either entity. Peters said if they wish to change anything, they will have no problem coming to the City Council for approval. Peters indicated that they will need help with maintenance on the facilities and felt it would be a good idea to be very specific as to who is

responsible for what. Maher said this could be accomplished with an agreement. Maher will draft a resolution for consideration by the City. Maher suggested the value of the property should be part of the document so that the contributing individuals or foundations will know that the City has a stake in the process. Councilman Owens moved to proceed with the preparation of the resolution and agreement. Motion carried unanimously.

STAFF-COUNCIL REPORTS

City Manager West reported that the curbs and sidewalks on the Museum Lane Project have been nearly completed and the paving is planned for next week. The contractor is making good progress on the curb/sidewalk construction work on the East Winnemucca Blvd. project. The City received the 60% progress plans for the sewer project this week and anticipates receipt of an updated cost estimate next week, which is expected to be just slightly higher than the \$21M original construction estimate. The Boys and Girls Club building design is roughly 75% complete and an updated cost estimate is expected next week. The Airport Board, by a split vote at last night's meeting, approved the MedX helicopter landing directly in front of the MedX hangar building at the airport.

Councilman Owens attended the RTC meeting.

Councilman Mavity attended the grand opening of the Animal Control Shelter.

Councilman Billingsley said the parking lot behind the Convention Center has some huge issues and the WCVA is working on fixing them. The expansion of the Event Center is still in the planning stage.

Mayor Putnam and City Manager West met with Jennifer Rose, Western Nevada Development Authority (WNDA) board member, and several County representatives regarding the City membership in WNDA. They are representing several counties at a meeting to discuss the location of I-11. The Winnemucca Domestic Violence services will be hosting their Second Annual Mayor's Ball on October 2, 2015.

The program is voluntary, not regulatory; provides savings to the homeowner; provides monitoring and inspection. If a system has failed, they help the owner identify parts of the system for replacement or repair.

- Jill Sutherland passed around thumb drives containing rough drafts of the model report for team review.
- Jill briefly described capture zones vs source water protection areas and looked at several of the PWSs as examples.
- Jill used the on-line Arc GIS Explorer tool to look at the various public water system capture zones
- Kim explained that some areas could be an area of interest such as those with high numbers of domestic wells because of the demand in those areas for drinking water.

3. Management Strategies and Implementation Measures/Actions

- The team reviewed the goals and objectives developed in December.
- Education and Coordination was discussed audiences in Humboldt and examples from other communities such as:
 - Nevada Outdoor School educates youth and can assist with adults in functions such as the Water Quality Summit.
 - General education on well and septic systems operations for home or business owners.

- o Sending letters to businesses in SWPAs to raise awareness.
- Fernley's program to provide a list of permitting required for potential businesses including looking if the area is in a SWPA.
- Agricultural community outreach regarding fertilizer use and storage and groundwater declines.
- A Permitting Package is desirable for Humboldt County. The appropriate County/City mechanism such as the Regional planning commission conditional use permit was discussed at length. Other potential mechanisms include protocol to contact Public Water Systems (PWSs) at time of application, use application process tied to industrial/commercial zoning (M1 for example), and site plan application requirements. This topic should be vetted further by the city and county to determine the best mechanism(s).
- A City-County-PWS Communication Process is desirable for new development, re-development, and non-compliance issues in SWPAs.
- A Water Quality Reporting Process is desirable for reporting quality and quantity to better understand and track the county water resources. Identify water level declines, water quality trends, and water use estimates.
- Focused Groundwater Study is requested to better understand threats to source water. The process would include identifying the area of concern, reviewing previous studies and data, determining new information needed, conducting a specific monitoring plan, and then appropriate actions, if needed, to protect source water.
- **Promote Wastewater Solutions** was requested including funding and planning for both "septic system management" opportunities as well as long range wastewater solutions. Continue consideration of wastewater collection/treatment or septic to sewer conversions, and funding opportunities or mechanisms.
- Improved Technology and Training is desirable. Better fiber optic cable band width and cell coverage is needed for communications between communities. PWS could use improved GIS, WiFi, and computer capabilities and training.
- Watershed Health and Groundwater Recharge are critically related. The County desires protocols for keeping unburned areas healthy,

rehabbing burnt areas, and SOPs for immediately following a fire. This can be addressed in the annual MOUs with cooperating agencies.

- o Watersheds can be prioritized for rehab
- Develop a protocol ready to use for watershed restoration after fire.
- Consider in watershed conversations with BLM, USFS, NDOW, etc.
- Hazardous Household Waste Disposal education is needed, and might include education about proper disposal and where to take it in various parts of the County.
- Septic System operation, maintenance and construction was discussed. In the Grass Valley area, Walt suggested that early on the systems were 12' deep and 40' long to leach downward. Currently the regulations are for 4' deep and are designed to leach upward.

- The team requested a link to the Douglas County Clean Water web page for review.
- The team requested to review the action plans from other CSWPPs.
- RCI will reach out to the public water systems individually regarding source water protection areas and action plans.

Ms. Borgzinner introduced herself and indicated she works with the Bureau of Wate Pollution Control. This bureau addresses the NPDES (National Pollutant Discharge Elimination System) permitting for waste water treatment plants and any discharges in the State. She is part of a regulatory program, but she is part of a voluntar program. She is the State Source Water Protection coordinator for the State. Her job is to work in this voluntary program with local communities to develop source water protection plans. These plans look at: where does your drinking water come from in the community; what land use activities are we doing above the ground from the sources that could impact the quality of the water that comes through these drinking water sources? They want to help us protect out plan, to protect out drinking water sources from adverse contamination. Ms. Boryzhner gave background information on how and why this program was established. She explained that the Water Pollution Control Bureau has contracted with Resource Concepts, Inc. Essentially her program gets enough money from the federal government to fund about \$270,000 a year and focus that money into Nevada communities for source water protection planning. Eight years ago they switched to a county wide approach by revamping the program. Ms. Borgzinner explained how this works, with her office acting as a facilitator to help build the team. She said that this is a county wide plan with every public water system participating. Everyone is working together to see where your water resources are and how you can best protect them. Ms. Borgzinner said they pick specific counties so they can put the entire amount into the community over a couple of years. This allows them to better use the funds available, they are able to focus in one area and get more done. The goal is to incorporate the protection areas into the Master Plan. She pointed out that this is a local plan, not a state plan. Ms. Borgzinner said they do a lot of public education. They want this to be a transparent process so everyone can participate and understand the issues. She explained what the program is not here to deal with. Some of those things are existing contamination issues, pre-existing drinking water quality issues like arsenic which is naturally occurring, water rights, or capital improvement projects.

RPC Meeting 4/14/16 Jill Sutherland, a civil engineer, with Resource Concepts, Inc. explained that the final plan will come out as the Community Source Water Protection Plan for Public Water Systems in Humboldt County. She further explained that source water is public drinking water, drinking water that comes from a regulated public water system. It can be privately owned or publically owned but is basically a system that serves drinking water to the public and is regulated through the safe drinking water program. Ms. Sutherland indicated there are 33 public water systems in the County. There are 7 community water systems which include the City of Winnemucca, McDermitt GID, and Golconda GID. There are 26 non- community systems which can be a bar or restaurant that are on their own water supply, mobile home parks, some of the NDOT rest stops, some of the mines. These encompass 41 different wells and 3 springs. They are here to assist the County with the plan development process. The first thing they do is form a local planning team and establish plan goals. That was started in October, November. They invited all the public water systems to participate. They went before the Board of County Commissioners and they invited them to bring this program to the County. There are other interested people such as the emergency services, educators/school district, the Nevada Outdoor School has participated. After contacting the public water systems, they have a staff hydrologist gather information about all of the individual wells and where they are located, the types of aquafers they are in. They, then run some simple ground water models that allows them to delineate areas around the well where you might have a higher risk of contamination. Ms. Sutherland showed a map indicating a year zone, a 5 year zone and a 10 year zone. These zones indicate the among of time it would take for potential contamination to get to your well. This gives you a target area to think about what sort of management strategies you want to come up with for those areas around the wellheads. The next step would be to look at the areas they have modeled and inventory the facilities or activities near the wells that might release pollutants. They then plovide mapping to the planning team. The planning team can then decide what type of management strategies fit our community and the different water systems and the different containinant sources. Ms. Sutherland gave examples of some of the things people decide to do to implement the plan such as education or community events. A water summit was held on March 9th at the convention center where the Neveda Outdoor School presented a physical model on water shed processes. Besource Concepts, Inc. also do some small infrastructure projects like well head security (fencing, bollards). Ms. Borgzinner's program provided the funding for that project. Ms. Sutherland indicated that another thing they do is help draft Master Plan language and updates for review. The current program goes a long way to fulfilling some of the goals and policies in the current Humboldt County Master Plan. Once the document, the plan, is created with management strategies and action items they come back to have the plan approved at the County and City levels and by the individual public water systems that have boards. She pointed out that this is a voluntary program, it is not mandated. It has to be developed by the community and the participation of the RPC would be fantastic.

Ms. Borgzinner said once the plan is approved by the Board of Commissioners that creates eligibility for the plan to receive funding for implementation from NDEP. It has to be approved before NDEP will provide funding. This is why they need everyone to get on board with the planning process and make it a plan that will work for the local communities.

RPC Meeting 4/14/16 Deputy District Attorney Carr asked about an agreement that was approved between with Resource Concepts, Inc. regarding a water plan. She asked if that is related to what they were talking about today. Ms. Sutherland indicated no that it is not related to what they are talking about today. The County Commissioners and County Administrator brought it up as a concern in the community. It is a water supply and water rights concern. They cannot deal with it under this program or any of the funding through Ms. Borgzinner's program. This is a separate project they will be doing through other people at Resource Concepts, Inc. Ms. Borgzinner indicated there is nothing restricting us from identifying these as issues in the plan. This plan and funding process will not be the means to address those issues.

Ms. Rock asked Mr. Mendiola which groups are participating in Humboldt County to start this. She knows this has been going on for close to a year that they started talking about water quality issues for example in Grass Valley and should there be a water plan. should that be included in the Master Plan. Mr. Mendiola indicated that this has been going on a lot longer than a year. Water has been talked about in many facets whether it is Grass Valley nitrate issues or water plans and out of basin water transfers. There are two issues, this particular one is more of an educational way to identify from a young age to adult how we get and maintain our drinking water. What are some of the concerns we might have to protect the water? That is the goal behind this plan. Separate from this plan is the water plan. The focus of the commission has been more about the out of basin water concerns. What they are trying to do from the County's and Commission's standpoint is there has to be a plan in place. He gave an example of litigation in Washoe County. One of the things that helped the litigants was there was a plan in place. The water had been earmarked for specific plans. What the county is working on with Resource Concepts, Inc. is to build the foundation for the water plan. Ms. Rock asked how often the Master Plan is looked at. Ms. Lawrence indicated that it was last updated in 2012. Ms. Rock asked at what point there might be people who are ready to sit down with them and start looking at modifications to the Master Plan. Mr. Mendiola said we would know more as the process is worked through. The group that is meeting is trying to identify action items that will come out of the data collected. From that there could be things in the Master Plan that could be affected. Ms Rook asked if it is appropriate at some point to have a subcommittee member work with the group. Mr. Mendiola said that he would like to see someone who can attend the meetings and get a sense of what they are trying to achieve. That person could then take the information back to the RFC and see if the board has any ideas. Mr. Bauman asked how many countres throughout the state NDEP and Resource Concepts, Inc. have worked with so far. MA Borgzinner indicated they have worked with 7 counties They have completed the entire Carson River Watershed so have done Douglas County, Carson City, Lyon County, Churchill County: They have had unanimous approval by all the communities and the plans have been incorporated into their Master Planning documents. They have completed Nye County and White Pine County, recently came into Humboldt County and are hoping to pick up two more counties over the next two to three years. Ms. Rock thanked Ms. Borgzinner and Ms. Sutherland for the presentation.

1. Welcome and Sign In

- Notably we had several new attendees including two Regional Planning Commission members, a NDEP representative for the non-point source program, and a representative from Paradise. A big thank you to all for coming.
- Jill Sutherland added files to thumb drives and provided thumb drives to the new attendees. The files were preliminary drafts of the two technical appendices and main body of the CSWP Plan:

2. Source Water Protection Areas

- RCI described source water protection areas and some of the alternatives. Locations maps were reviewed using Arc GIS on-line.
 - General agreement to locations with 1000-foot SWPA designation.
 - General agreements to 10-year Time of Travel SWPAs in McDermitt and Paradise Valley. The Team discussed that

McDermitt SWPA will overlap into Oregon, as well as public and private lands.

- Kim suggested keeping the larger existing SWPAs for the two Orovada Alternatives, unless there was compelling data to make them smaller.
- General agreement to keep the existing 20-year Time of Travel SWPA for the City of Winnemucca, expanded to included modeling of the proposed Well 8 location
- For the three Grass Valley Area Alternatives, the group indicated a preference for SWPA boundaries established along parcel lines. It makes sense in this area where there are smaller parcels.
- Vickie requested a list of pros and cons for the alternatives in the Grass Valley area.
- The team in general liked the "areas of interest" to be considered in the CSWP Plan for encouraging development and protecting groundwater recharge.
- The Team reviewed BLM lands designated "wellhead protection zones" and "priority watersheds for municipal water supply".
 - Discussed the relationship to existing Wellhead Protection Areas.
 - o Discussed the potential pros and cons for new SWPAs.

3. Management Strategies and Action List

- The team discussed the potential role of land management agencies where SWPAs overlapped or were in close proximity to public lands.
 - The team concerned that local voluntary SWPAs, which overlap onto federally managed lands, could be misinterpreted by land management agencies to hamper surface activities and ROWs for access.
 - The team agreed to add verbiage encouraging economic development compatible with source water protection in the Goals and Objectives of the CSWP Plan.
 - Needs to be further addressed in the CSWP Plan and potentially the Regional Master Plan.
- We briefly reviewed the Management Strategies
 - Vickie requested e-mailed copies of educational materials.
 - We discussed assistance available by RCAC and NvRWA.

- The team suggested developing and disseminating a living Orientation Handout:
 - Containing important phone #s (Barbara has a 3 ring binder with all of her numbers)
 - There is a need for more information between more people more often.
- The team discussed other information/training/assistance needed by small PWSs.
 - A Resource Guide for all public water systems.
 - The team requested a Grant Guide applicable for their types of projects.
 - The team suggested a series of public workshops in the Grass Valley area regarding wells and septic systems.
 - The Annual Meeting to review the CSWP Plan and implementation would appropriate in January each year: after new Board members in office and while next year's budget is being developed.
 - The PWSs need help to "Hand Off" their duties to new people.
 - The PWSs and GIDs need contacts for appropriate staff at the State of Nevada.

4. Plan and Approval and Implementation

- Preliminary discussion on the relationship of the CSWP Plan to the Master Plan.
- General indication from the team the CSWP Plan should be included in the Master Plan, but timing of that effort uncertain. Assistance would be needed for a Master Plan update.
- Revisit adoption process at next Team Meeting.

1. Welcome, Sign In, Overview of Meeting

- The Jury Room was a bit snug for our group with standing room only.
- 2. Source Water Protection Area Review Grass Valley
 - Three different Source Water Protection Areas were presented,
 - o the small area centered on the high density septic system area,
 - o the medium area encompassing the 20-year capture zone and
 - the larger area which encompassed all of Grass Valley on the south side of the Humboldt River to the County Line and the Rose Creek area as well.
 - The team liked the different scenarios to accommodate different needs.
 - Barbara pointed out that the SWPA should deal with newer development (the larger area) and what is already there to be managed.
 - Land development in the Grass Valley area is constrained by the septic system density limitations as well as the need to have water rights of 2 af/parcel (Paradise and Winnemucca also need water rights for smaller lots).

- Consider adding in the Master Plan, triggers when the # septics/mi² is exceeded. Perhaps deed restrictions of septic tanks maintenance programs like an HOA (Betty said this was not possible). Perhaps form a GID. Consider for new developments.
- Kim explained how the state looks at septic densities, which is a ½ mile radius around the proposed project. (Each hydrographic basin is different. In Grass Valley the allowable density is 81/sq mi.)
- A management strategy could be a study, a targeted document regarding areas where the county wants to be free from restrictions with a specific purpose for the state with justifies reasons. Jim was hoping the SWPA and water plan would do this.
- The Team requested Fred at UNR to come out and give a presentation regarding financing options and opportunities.
- Walt brought up denitrifying systems and the problems with them for testing and maintenance. Kirk agreed and the only way to make them work would be to have 5-6 homes on one system.
- Jim asked what are the regional sewage treatment options. Concerned that hook-up fees are higher than the value of the homes.
- Kim explained what Lyon County was able to do in the Mark Twain area.
- The Team suggested that one of the management strategies include an updated engineering feasibility study with options for costs building on efforts from the past studies.
- The Team suggested that we keep all three SWPAs and AOIs discussed at the meeting.
- Kirk suggested that the County require that septic tanks are pumped when the property is sold.

3. Management Strategy and Implementation Review

- Discussion included relationship to the BLM lands suitable for disposal and the Sage Grouse Land Use Plan Amendment (LUPA) which restricts essentially all uses.
 - Humboldt County is currently in a suit to get the BLM to describe how the LUPA will be enforced.
- Kirk pointed out that key areas suitable for sewage disposal should be

identified so that they do not become developed (on private or on public lands available for disposal).

- Any lands needed for public uses should be identified in a GIS layer and if does not exist then can be identified for assistances if County cannot do it in house
 - to help deal with the Sage Grouse LUPA;
 - Lands also should to be identified in the Master Plan.
- Jill presented some options for a new goal. Regarding the new goal, the team after much discussion, selected the following. Some supporting objectives/action list items were also outlined based on the discussion.

Promote compatible economic development within Source Water Protection Areas and identified Areas of Interest.

Objectives/Actions: Ordinance for density, consider vulnerability of the aquifer or wells to contamination, develop definition of "compatible" (for example facilities falling under the State's Chemical Accident Prevention Plan (CAPP) requirements).

- Brad suggested that considering contaminants and high soil mobility could be considered in the vulnerability of the well/aquifer.
- Jim suggested that the Master Plan should be updated and include the CSWP and water plan information.
- Vicki would like to discuss the Master Plan and what all should be in it with RCI. Jill pointed out the current Master Plan has identified specific elements that need to be developed, which could guide the future discussion.
- Briefly reviewed potential areas desired for future development: residential/commercial near Well 8 to the east, the industrial area along Jungo Road to the west. Zoning/land use designation might warrant review in coordination with any Master Plan updates.

1 Welcome, Sign-in, Introductions, Overview of Meeting (RCI)

The City Fire House is a nice venue for meetings complete with a screen and projector.

2 Action Plan review (Appendix E)

RCI and NDEP reviewed the Integrated Source Water Protection Program (ISWPP) plan development and implementation process with the Team. They discussed availability of grant money and technical assistance for implementation of Community Source Water Protection Plans, both for immediate priorities in Humboldt County and longer term measures. To be eligible for funding and technical assistance by NDEP, implementation projects must be listed as Actions in the approved plan.

RCI presented a modified format for the draft Action list that included proposed actions and columns to note responsible groups for implementation, desired schedules and priorities. This preliminary format would help with future decision making by the Team to request assistance from the ISWPP and other programs.

The Team discussed the general format of the Education and Outreach part of the Action Plan. Comments included:

- The plan needs to build on the state wide education program for wellhead protection not just a standalone effort. There is a benefit to building a State-wide approach since issues are the same in many Nevada communities.
- The plan identifies other groups/agencies that can partner with the communities and County for education and outreach The non-profits organizations, for example, Nevada Rural Water Association (NvWRA) and Rural Community Assistance

Corporation (RCAC). The Nevada Outdoor School already has a great program in place and could use additional source water protection messages in their program.

- There is a lot of technical information available about source water protection and septic system operation, but local expertise is needed to determine the method and cost to reach audiences in Humboldt County.
- Outreach methods are changing and younger people use social media and there should be a component of the outreach and education actions that includes social media.
- The Action list does not clearly relate the Education and Outreach to the overall goals of the Community Source Water Protection Plan. Appendix F provides a standalone Education Plan the details the approach, including target audiences, outreach measures, specific messages, etc. It is an important component of the overall plan and is required by NDEP. Vicki had several suggestions regarding weaving education into the various components of the Action list rather than grouping them under one Management Strategy.

The Team discussed the Actions for physical improvements. Comment's included:

- Backflow prevention is required by NAC in many circumstances. In addition to physical improvements, promoting backflow prevention should be a component of the education and outreach plan.
- Fiber optic utilities are being installed in Winnemucca, but the smaller communities still have limited capabilities. Assistance with technology improvements on a broad basis should be included as an Action.

The Team discussed the management strategies under "Planning and Funding" touching on several items in the Action list. Additional review is needed for management strategies and actions listed under "Resource Investigations", as well as "Coordination and Collaboration". RCI will follow up with Team Members for further review and comment.

NDEP offered comments to the Team regarding balancing the Action list to include both very focused specific actions, as well as broad based actions that allow flexibly in addressing future needs for assistance. NDEP indicated that in the future communities with approved plans throughout the State may be competing for technical and resource assistance. From the Action list, a scope of work would be submitted to help NDEP prioritize assistance.

The Team's comments included:

- use less acronyms and more whole words
- put the stronger, higher priority items at the top of the lists

- Use words like "review and evaluate" and "implement as appropriate" instead of "consider" and "collaborate".
- The highlighted Actions in the draft provided to the team were not appropriate in this plan and could be removed from the list.
- Star City Properties is already coordinating with the County regarding ownership and the action does not need to be added to the plan.

3 Education Plan Review (Appendix F)

Provided but not reviewed at this meeting. RCI to follow up with Team members and specifically Vickie, who has input on format and content. Moved on to next agenda item.

4 Water System Data Security and Disclosure

RCI reviewed the concerns that public water systems must consider for security, including limiting information that is available to the general public about well locations and construction. The Team discussed the level of information that should be included in the Community Source Water Protection Plan as the draft document is:

- provided to them for review,
- considered for approval in public meetings by various boards, and
- available to the public once the Plan is approved.

After reviewing the draft source water protection area maps and a hard copy of the plan developed for Churchill County, the Team suggested that:

- Source water protection area outlines on maps should be included in Appendix A and were not detailed enough to pose a problem. They could be made available to the general public.
- The well locations and information in GIS format could reside with the County GIS department, which is considered secure.
- For review by the various boards at public meetings, the body of the Plan as well as appendices with no sensitive materials would be provided to the public. Appendices with sensitive information would be available at a secure location for review, such as the County offices.
- RCI will coordinate further with the Team and County attorney regarding the review and adoption process to be consistent with public meeting requirements and the applicable Nevada Revised Statues.
- RCI will contact the City to discuss how their wells and information are displayed, since they were unable to attend today's meeting.

5 Process/Schedule for Plan Review and Adoption

RCI and the Team discussed the process and timeframe to review the draft documents and obtain approvals of the final Plan. The Team goal at this time is to:

- Present the Plan to Regional Planning Commission and request a letter of support for adoption of the plan at the City and County level.
- Provide the Plan to participating public water system boards/owners and request them to approve the plan and/or provide a letter of support for adoption of the plan at the County level. RCI and NDEP will be available to make presentations if requested.
- Present the Plan, including letters of support, to the City Council and County Commission with a request to adopt the Plan.

- Gold Country Estates had to shut down a well due to nitrate contamination (13-14 ppm). Many wells are at 8 or 9 ppm nitrate. Under Winnemucca Farms it is over 100 ppm.
- Rex suggested that Source Water Protection education be included in the periodic safety meetings which are held monthly. Guest speakers can be coordinated with safety manager. They have 90 employees that live in the area. We should consider doing the same at the mines since these are residents of the county.
- A joint Kings River, Orovada, and McDermitt Source Water Protection education event would be beneficial and we should schedule with the teachers.

3 Next Steps

RCI and the Team discussed the process and timeframe to review the draft documents and obtain approvals of the final Plan. The Team goal at this time is to:

- Provide the Plan to participating public water system boards/owners and request them to approve the plan and/or provide a letter of support for adoption of the plan at the County level. RCI and NDEP will be available to make presentations if requested.
- Present the Plan, including letters of support, to the City Council and County Commission with a request to adopt the Plan.
- All information to boards and GIDs should be provided 10 days in advance to ensure it gets on the agenda. We should send this with staff summaries. Hard copies are helpful because the small GIDs don't have copiers.



Purpose & Overview

The purpose of this meeting was to discuss the Humboldt County Community Source Water Protection (HC CSWP) Plan Update.

Discussion

1. Welcome and Introductions

The meeting began with a brief overview of the Agenda items.

2. 2016 CSWP Plan Signed Resolution

Humboldt County (HC) reviewed both the 2016 signed resolution (HC Board of Commissioners approval) and the 2020 resolution adopting the HC CSWP Plan as part of the Humboldt County Master Plan. The Group does not currently have a signed copy of the 2020 Resolution. Humboldt County gave the Group some insight about the process which may need to unfold to approve the 2023 Update, including:

- Write an amendment to the 2016 Resolution for the HC Board of Commissioners (BOC) to adopt the 2023 HC CSWP Plan update,

 - The CSWP Plan update can coincide with the Master Plan update, and
 - The HC 2020 Water Plan and the HC CSWP Plan will be referenced in the Public Lands Policy and the Master Plan update.



- HC will need to reach out to the District Attorney for more guidance on the process and procedure for the CSWP Plan update, and
 - A Group meeting with the District Attorney ma be appropriate once the 2023 Update timeline and process has been finalized.

3. Key CSWP Plan Updates

The Group reviewed key updates to the CSWP Plan, including:

- Updates to the Main Body,
- Appendix E, the Action Plan, and
- Appendix F, Education and Outreach.
- RCI agreed to highlight sections of the CSWP Plan which need to be reviewed by the City of Winnemucca,
- Reference the 2020 Water Master Plan and Goals and Policies that support source water protection (SWP),
- The update will be sent out to all of the participating water systems for review before it is finalized and presented to the commission,
 - RCI will reach out to the 2014 participating water systems to let them know an update has begun, and
 - o RCI will reach out to Michelle Cook for updates to contact information.
- A public meeting by HC to provide an overview of the CSWP Plan and key updates may be appropriate,
- Three new water systems may need source water protection area (SWPA) maps,
 - o RCI will provide DRAFT SWPA maps to HC in the form of pdf and GIS, and
 - HC will review the SWPA maps to make an informed decision about adding them to the CSWP Plan update.
- One future well for Gold Country Estates, recently acquired by HC, may need a new SWPA model, and

Discussion

1. Welcome and Introductions

The meeting began with a brief introduction from each meeting attendee.

2. What is the CSWP Plan for PWSs in Humboldt County?

Humboldt County provided a brief description of the 2016 CSWP Plan, and provided RCI with background information regarding the Emergency Operating Plan (currently being updated), and additional County Plans in the works, including the Mutual Aid Plan being developed in partnership with the City of Winnemucca and Lovelock. The goal for Humboldt County is to maintain consistency across all County-Wide Plans. It is important to Humboldt County to find the crosswalks between plans, and include those crosswalks in any updates.

3. Key CSWP Plan Updates

 - HCEM has a positive relationship with the BLM, and the group agreed that it would be a
 positive step forward and good collaborative effort to include the BLM in the CSWP Plan
 update review committee.
- Wildfire: Watersheds have burned in the past, and the community has prioritized protecting water sources from the effects of increased runoff and exposure to contaminated soils.
 - Includes recharge areas for groundwater supply, and
 - Response and remediation.

4. Review Section 3.5 of CSWP Plan – Contingency Plans

RCI provided a brief review of Section 3.5. RCI will update references to the emergency and hazardous materials pertinent plans. HCEM agreed to:

- Read through and provide additional County references and/or contingency measures,
- Include the CSWP Plan into updates to the:
 - Hazardous Waste Plan,
 - Regional Emergency Management Plan, and
 - Humboldt County Emergency Management Plan.


The meeting began with a brief introduction from each meeting attendee.

Purpose & Overview

The purpose of this meeting was to discuss the on-going update for the Community Source Water Protection Plan for Public Water Systems in Humboldt County (CSWP Plan).

Prior to the meeting, RCI provided the City of Winnemucca (City) with a OneDrive Folder with highlighted sections of the CSWP Plan for the City's review. The City Manager/City Engineer reviewed and commented on the highlighted sections – Thank you!!. The group reviewed and discussed the City's comments in the meeting.

Discussion

1. Welcome and Introductions

The meeting began with a brief introduction from each meeting attendee.

2. Updates to the CSWP Plan main body

Discussion about the City's comments on the main body, including:

- The New Well 8 has been drilled, and this likely corresponds to the *New Well 8* in the Safe Drinking Water Information System (SDWIS).
 - o City Manager will send RCI the coordinates, the well log, and the pump tests,
 - Following hydrogeologic studies, and a test well, the previous location identified in the 2016 CSWP Plan was not used,
 - Lithium Nevada plans to assist to install a pump and activate the New Well 8 by 2024 (estimated timeframe),
 - RCI will investigate a change in the source water protection area (SWPA) simulation for the City to review,
 - Should the SWPA be significantly different relative to 2016, the City may choose to update in the CSWP Plan.
 - RCI should use a maximum pumping rate of 1,000 gallon per minute (GPM) for the simulation per the anticipated design per the City Manager, and



- In the event the SWPA boundary changes, RCI would not retain the previous Well 8 location on the inventory list.
- The group discussed a potential future well location at "Well 1":
 - Well 1 has not been drilled,
 - The City has water rights for the "Well 1" location,
 - The City will send RCI the water right permit number and a kmz or the parcel number and/or location of the future well.
 - There is likely no new rapid development near the potential well location; however, there are two commercial parcels near the well, and a major stormwater ditch that might warrant consideration of a source water protection area,
 - The group agreed that RCI could run a simulation for "Well 1" to be reviewed the City,
 - RCI should use 1,000 GPM per the City Manager, and
 - RCI can use the well log from the closest municipal well for additional simulation data.
 - RCI can add a future "Well 1" in the text of the CSWP Plan Main Body for review by the City, for example, a few sentences about the water rights and the potential of "Well 1" location.
- The City informed the Group that their 2000 Wellhead Protection Plan (WHPP) was updated in 2008.
 - They agreed to send an updated copy of the 2008 WHPP to RCI for reference.
- The City reviewed existing source water protection achievements, including:
 - The Wastewater Treatment Plant was updated in 2017 removing the old holding ponds as a potential contaminant source, and
 - The City completed a new water system model which allows them to simulate various emergencies, such as what they will do should one well go down (contingency planning accomplishment for the CSWP Plan).

3. Updates to the Action Plan

Edits and comments on the Action Plan, included:

- Remove the City from Action Project 1.1j,
 - There are only a few septic systems in the City and they don't mention septic maintenance in their Consumer Confidence reports (CCR),
 - It is a City priority to limit septic systems, and if new developments are within 400 feet of water and sewer, there is an ordinance that requires the development to connect,
 - The City also requires that should a septic system fail, and should there be available water and sewer lines near the home, the homeowner is required to connect,
 - Their plans for development do not rely on septic systems, and will expand water and sewer to three new areas, including Aida Vista and Hargrave Lane, and
 - RCI will add this ordinance to existing measures the City is taking to protect source water in the Main Body.



- Mark Action Project 5.2e as completed for the City, as:
 - The City completed a feasibility study on how to remediate arsenic levels Well 6, which have since gone down to acceptable levels below the Maximum Containment Level (MCL).
